

Belfast MIPIM 2020 Sponsorship Terms and Conditions

This page sets out the Terms and Conditions upon which Belfast City Council provides the MIPIM 2020 Sponsorship Packages. By submitting the MIPIM registration form you are confirming that you accept these Terms and Conditions and that you agree to comply with them. If you do not agree to these Terms and Conditions, your application will be automatically disregarded.

1. Bookings

(a) Submitting a MIPIM registration form constitutes an offer by you to request participation in Belfast MIPIM 2020 in accordance with these Terms and Conditions.

(b) The request for participation set out in 1(a) above shall be deemed to be accepted when we issue confirmation in writing that your request for participation has been accepted ("Confirmation") at which point and on which date the contract for the participation shall come into existence ("Commencement Date").

(c) No request for participation in MIPIM 2020 shall be deemed to have been accepted by us unless you have accepted the Terms and Conditions by submitting the MIPIM registration form and we have provided the Confirmation. We reserve the right to reject any request for participation.

By submitting a MIPIM registration form you agree to Lanyon Communications Limited (Company Number NI062387), the appointed event management delivery partner for Belfast MIPIM 2020, contacting you for the purposes of organising MIPIM 2020.

2. Cost of packages

The following Sponsorship packages are available: Headline Package £35,000, Platinum Package £18,000, Gold Package £10,000, and Silver Package £6,500.

3. Payment

We will send an invoice to you for the full price of the package you have selected with our Confirmation. Payment in full is due within 30 days of the date of our invoice. No package rewards will be made available until we receive full payment of the invoice amount.

For Platinum sponsors wishing to participate in the Autumn Investor meeting in London, full payment must be received before the 31st October 2019.

4. Additional charges

We will invoice you for any additional charges (such as additional delegate fees, additional sponsorship opportunities etc), we incur on your behalf, which shall be due and payable within 30 days of the date of our invoice. Additional charges that are incurred in currency other than sterling will be invoiced to you in sterling at the exchange rate prevailing at Barclays at the date of invoice.

5. Allocation of additional sponsorship opportunities

All package features and additional sponsorship opportunities will be allocated on a first come, first served basis and receipt of all payments due. Due to nature of the MIPIM 2020 event, we reserve the right to make changes to the package features and sponsorship opportunities available and to substitute alternative options of an equivalent value.

6. Advertising

You agree to provide us with advertising copy and your logo for inclusion in the Belfast Investment Guide, investinbelfast.com website and Stand before any deadline specified by the Event Management delivery partner – Laynon Communications Limited or the Council. If you fail to meet this deadline your entry in the publicity materials will be cancelled and no credit against the package price will be given.

7. Advertising copy content

By submitting your advertising copy to us you confirm that its contents are a true and fair statement of the services or facilities provided by you and that it does not contravene the provisions of any applicable law. You also confirm that such advertising copy does not infringe the rights, including any intellectual property rights, of any third party and agree to indemnify us against all costs, expenses and liabilities we incur as a result of any claim for infringement of such rights by any third party.

8. Publication of advertising copy

We will make all reasonable efforts to ensure the accurate reproduction of the advertising copy supplied by you, however, we will not accept liability for any errors or omissions unless they arise as a direct result of our negligence in which case our liability to you is limited to the cost of the advertising materials irrespective of the participation package price.

9. Liability

We will have no liability to you or to any other person for any loss of profit, economic loss or goodwill or for any special, indirect or consequential loss. Save as set out below our total liability to you is capped at your participation package price. Nothing in these Terms and Conditions excludes or limits our liability for our fraud or for death or personal injury caused by our negligence.

10. Indemnity

You shall indemnify us against injury to any persons and any loss of or damage to any property caused by your negligence or that of your employees, agents, subcontractors and / or guests or arising out of or in connection with your participation at MIPIM 2020.

11. Amendments

You may make a change to your delegate details provided you notify us in writing of any requested change. If we incur any charges for making your requested change we will invoice such charges to you as an additional charge.

12. Venue

The Belfast stand for MIPIM 2020 is located on the Croisette, Cannes. It is not however a term of these Terms and Conditions that any particular venue is to be used to host MIPIM 2020 and if a venue which we intend to use to host MIPIM 2020 becomes unusable due to flood, fire or such similar occurrence or is not available for any other reason, we will endeavour to find a suitable alternative venue and notify of you of the change of venue in a timely manner.

13. Cancellation

If, because of circumstances beyond our reasonable control (including but not limited to an inability to find a suitable alternative venue under clause 12 above), we decide to cancel MIPIM 2020, we shall notify you of the same in a timely manner. We shall not be in breach of these Terms and Conditions as a result of such cancellation however you will be entitled to cancel your participation in writing within 14 days of such notification and seek a refund of all monies you have paid to us, less an amount calculated and deducted by us, acting in good faith, representing an apportioned share of our costs, disbursements and expenses (including administrative expenses) related to MIPIM 2020.

If you cancel your participation in Belfast MIPIM 2020 at any time, you must inform us in writing. The full price for your sponsorship package will be payable in the event that you cancel.

14. Copyright

The sponsor can only use the Council's Logo and/or MIPIM 2020 logo after receiving written approval from the Council to do so. Logos can be obtained from the Community Services Unit. Where the Council's logo is used it should be accompanied by the following statement "this publication is connected as Sponsor to Belfast MIPIM 2020. The views expressed are not necessarily shared or endorsed by the Council. The Council does not accept any responsibility or liability for same.

15. Law

These Terms and Conditions shall be governed by and construed in accordance with Northern Irish law and both parties agree to submit to the non-exclusive jurisdiction of the Northern Irish courts.

16. Privacy
